If you are ready to schedule, then the next step is to click on the ESIGN on your emailed document and this will allow you to accept any options that you may or may not want. Once you complete this task. It will be emailed to the office and ASF will be reaching out to you via email within 24 hours. ASF will be giving you some dates that currently work. ASF will not confirm your dates unless they hear back from you. Please note that ASF will do our best to make sure that the schedule dates don't move. But sometimes our jobs run over due to weather, mechanical failures, change orders, etc. With this in mind, in the event that this happens. ASF will be in contact to let you know of any changes.

We ask that if you have any notes on your proposal that need to be done prior to ASF arrival is complete before arrival. In the event ASF arrives on site and if the job is not ready for our crews we will have to charge a \$500 mobilization fee unless noted on the estimate. Please don't hesitate to reach back out to ASF and schedule another day for your salesperson to come back out and do another walkthrough prior to our crew arrival if you have any concerns.

If ASF is working in your attic we would need to have the water and hvac unit turned off prior to starting work. If we are working in the crawl space we would only need the hvac unit turned off if the ducts are under the home. Both systems can be turned back on at the end of the day.

If we are to schedule our work with other subcontractors, termite company, hvac company, carpenter, or sheet rocker, we would need to have an email created between you, your chosen company and ASF.. We do this to properly schedule your project with all parties involved.

Per SPFA no one should be in the home when spray foam is being installed and the house should be vacant for 24 hours to properly ventilate the space.
